

REGISTRATION / RECORDATION APPLICATION INSTRUCTIONS

1. Member number is assigned by registry.
2. Breeder - the owner or lessee of Dam at time of mating.
3. Owner - the owner or lessee of Dam at time of lambing.

ANIMAL TO BE REGISTERED / RECORDED

- 4A. Name of animal (lamb) - Farm name or abbreviation plus animal name.

2025 Animal names must start with M

2026 Animal names must start with N

2027 Animal names must start with O

2028 Animal names must start with P

- 4B. Scrapie tag Number (i.e. MN1234-001)

5. Date of birth

6. Sex - R for Ram, E for Ewe, W for Wether

7. Birth Type - S for single, TW for twin, TR for triplet, Q for quadruplet.

8. Breeding Type - Nat for Natural, AI for Artificial Insemination,
ET for Embryo Transfer or IVF In Vitro Fertilization

9. VBN% - Valais Blacknose percentage. All lambs F1 and higher must be DNA tested parent verified. Wethers are NOT required to be DNA tested to receive Recordation papers.

10. DNA Verified (Required for all Rams & Ewes) Associated Registry will send a submission DNA form via email to mail in with your hair sample to UC Davis. Instructions on how to collect a hair DNA sample can be found on VBSANA.com.

11. VBSANA Reg # - Number assigned to ram by VBSANA. Numbers will be listed on website for approved rams. Go to: Member Area > Sheep Search > Registration #

12. Name/Tag # - Information is listed on website for approved rams.

13. VBN % - Rams used through generation four (F4) must be 100%. NO crossbred rams will be accepted for breeding until the fifth generation (F5). Breed up ewes, and rams F5 or greater must be approved for registration by the registry, by submitting pictures of ram to be registered, identifying the rams tag number and all its breed characteristics.

14. DNA Verified - All rams must be parent verified.

15. VBSANA Reg # - Number assigned to ewe by VBSANA.

16. Name/Tag# - If no name, use farm name and tag number.

17. VBN% - Foundation ewes are 0%, purebreds are 100%
